Counseling program reached 166 clients in 2022, ranging in age from 5 to 75. We provided 2,446 sessions via telehealth, in-office sessions, and in-school sessions. We had a reduction in expenses for our Counseling program due to having one less FTE for 6 months out of the year.

Intervention program reached 188 youth in 2022, ranging in age from 5 to 15. We provided 383 sessions through classes, individual programming, and homework. Additionally, our Linwood Intervention program provided 300 sessions (duplicated).

Enrichment program reached 121 youth in 2022, ranging in age from 5 to 15. We provided 1,108 sessions through our Youth First classes and Safety Camp.
